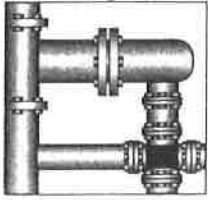

**SUMMARY ANNUAL REPORT FOR  
CONNECTICUT PIPE TRADES LOCAL NO. 777 ANNUITY FUND**

This is the summary annual report for the Connecticut Pipe Trades Local No. 777 Annuity Fund (Employer Identification Number 06-1441857, Plan No. 001) for the period July 1, 2017, through June 30, 2018. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the Plan are provided by a Trust. Plan expenses were \$5,587,887. These expenses included \$5,253,800 in direct benefit payments paid to participants and beneficiaries, and administrative expenses of \$334,087. A total of 3,613 persons were participants or beneficiaries of the Plan at the end of the Plan Year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$143,810,319 as of June 30, 2018, compared to \$126,137,365 as of July 1, 2017. During the Plan Year, the Plan experienced an increase of \$17,672,954 in its net assets. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had a total income of \$23,260,841 including \$11,289,787 in employer contributions, a gain of \$3,810,600 from the sale of assets, earnings from investments of \$8,023,113 and other income of \$137,341.

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the Fund Office located at 1155 Silas Deane Highway, Wethersfield, Connecticut, 06109-4318, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
