SUMMARY ANNUAL REPORT FOR CONNECTICUT PIPE TRADES LOCAL NO. 777 ANNUITY FUND

This is the summary annual report for the Connecticut Pipe Trades Local No. 777 Annuity Fund (Employer Identification Number 06-1441857, Plan No. 001) for the period July 1, 2015, through June 30, 2016. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided by a Trust. Plan expenses were \$4,430,241. These expenses included \$4,077,811 in direct benefit payments paid to participants and beneficiaries, and administrative expenses of \$352,430. A total of 3,287 persons were participants or beneficiaries of the Plan at the end of the Plan Year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$109,261,105 as of June 30, 2016, compared to \$104,139,090 as of July 1, 2015. During the Plan Year, the Plan experienced an increase of \$5,122,015 in its net assets. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had a total income of \$9,552,256 including \$9,845,739 in employer contributions and a net loss on investments of \$293,483.
