TO ALL EMPLOYERS OF CEMENT MASONS UNION LOCAL 502 - PLASTERERS AREA 5

This will officially serve to inform you that on June 1st, 2019 a \$2.25 increase will be effective in accordance with our Three Year Contract Agreement. At a Special Meeting of the membership on May 11, 2019 the members voted to allocate \$1.25 in the category of WAGES and \$1.00 in the category of FRINGES.

In the category of FRINGES, the members voted to allocate an additional \$.60 to the PENSION FUND, \$.25 to the HEALTH & WELFARE, and \$.15 to the APPRENTICE FUND. WORKING DUES will remain at 4.5% of the total package. The rates effective June 1, 2019 to May 31, 2020 are as follows:

*NOTE: Effective June 1st, 2019 the effective date of the rates is changing to May 31st annually.

**NOTE: Working dues will now be deducted at \$3.50 per WORK hour with no adjustment for OVER TIME or DOUBLE TIME.

APPRENTICE RATES ARE AS FOLLOWS:

Based on the following percentages of the Journeyman Wage.

(1)	1 st 6 months	50%	\$22.25 per hour
	6 months to 1 year	55%	\$24.48 per hour
(2)	1 year to 1.5 years	60%	\$26.70 per hour
	1.5 years to 2 years	65%	\$28.93 per hour
(3)	2 years to 2.5 years	70%	\$31.15 per hour
	2.5 years to 3 years	75%	\$33.38 per hour
(4)	3 years to 3.5 years	80%	\$35.60 per hour
	3.5 years to 4 years	85%	\$37.83 per hour

Dues deductions for Apprentice Plasterers shall be \$3.04 per hour.


We urge all employers to bring an Apprentice into the Union through your company and provide equal opportunity to qualified female applicants. You can also call the Union for a list of applicants.
