TO ALL EMPLOYERS OF CEMENT MASONS' UNION LOCAL 502 - PLASTERERS' AREA 5

This will officially serve to inform you that on June 1, 2020 a \$2.35 increase will be effective in accordance with our **Three Year Contract Agreement**. At a Special Meeting of the Executive Board on April 16, 2020 the Executive Board voted to allocate \$.50 in the category of **WAGES** and \$1.85 in the category of **FRINGES**.

In the category of **FRINGES**, the Executive Board voted to allocate an additional \$.85 to the **PENSION**, \$.75 to the **HEALTH & WELFARE**, and \$.25 to the **RETIREE WELFARE**. **WORKING DUES** will remain at 4.5% of the total package. The rates effective June 1, 2020 to May 31, 2021 are as follows:

APPRENTICE RATES ARE AS FOLLOWS:

Based on the following percentages of the Journeyman Wage.

(1)	1 st 6 months	50%	\$22.50 per hour
	6 months to 1 year	55%	\$24.75 per hour
(2)	1 year to 1.5 years	60%	\$27.00 per hour
	1.5 years to 2 years	65%	\$29.25 per hour
(3)	2 years to 2.5 years	70%	\$31.50 per hour
	2.5 years to 3 years	75%	\$33.75 per hour
(4)	3 years to 3.5 years	80%	\$36.00 per hour
	3.5 years to 4 years	85%	\$38.25 per hour

Dues deductions for Apprentice Plasterers shall be \$3.10 per hour.

We urge all employers to bring an Apprentice into the Union through your company and provide equal opportunity to qualified female applicants. You can also call the Union for a list of applicants.
