This is a summary of the annual report for CONTRACTORS LABORERS TEAMSTERS & ENGINEERS HEALTH & WELFARE PLAN, EIN 47-0469477, Plan Number 501, for the period January 1, 2008 to December 31, 2008. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has (a) contract(s) with UNITED OF OMAHA INSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan:

The total premiums paid for the plan year ending December 31, 2008 were \$53,000.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$13,130,750 as of December 31, 2008, compared to \$14,260,306 as of January 1, 2008. During the plan year the plan experienced a change in its net assets of \$-1,129,556. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$8,074,743 which included employer contributions of \$7,880,636, employee contributions of \$166,981, gain/loss of \$40,097 from the sale of assets, and earnings from investments of \$-12,971.

Total plan expenses were \$7,571,089. These expenses included \$528,389 in administrative expenses and \$7,042,700 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
