Dear Participant:

The opioid epidemic has become an increasing concern nationally, locally and within the ranks of the Toledo Electrical Welfare Fund's covered population. To coordinate opioid prescription coverage with prevailing state law and Center for Disease Control guidelines, new benefit limitations and prior authorization requirements will be applied to the dispensing of opioids. This program will go into effect **June 1, 2018.** 

Here are the changes that will be implemented:

- The day supply for opiates will be limited to 7 days per prescription.
- For people in a first fill situation, only 2 prescriptions will be covered within a 60-day period.
- Prior authorization will be required for a 3<sup>rd</sup> prescription or for dosages exceeding Center for Disease Control guidelines.
- For people already in a pain management regimen excluding oncology, palliative care and hospice patients – a prior authorization will be required for dosages exceeding Center for Disease Control limitations.
- All Extended Release Opioids will require a Prior Authorization.

If you are concerned that these changes will impact you or a family member, please call AmWins, TEWF's Pharmacy Benefit Manager, to explain your situation. Accommodation will be made to ensure ongoing access to your prescription benefit in a clinically appropriate fashion. You can reach AmWins Clinical Review Department by calling 1-877-274-7871, and then select "2". AmWins can assist you in answering questions about your prescription benefits and your pain treatment regimen.
