Information Collected

North Atlantic States Carpenters Funds may collect public and non-public personal information about you or your dependents from any of the following sources:

- On this website when you provide information about you (for example, name, address, phone number, date of birth, and email address)
- Offline interactions between North Atlantic States Carpenters Funds and you or your organization (for example, discussions with our customer service staff or written communications)
- Interactions between North Atlantic States Carpenters Funds and third parties we work with to provide services to you and to administer your benefits.

Use of Information Collected

North Atlantic States Carpenters Funds takes great care to protect your personal information. When we use it, we do so with respect for your privacy. We may use personal information about you to service and maintain your account(s) with the Funds; process transactions in your account(s); respond to inquiries from you, administer the Funds' Plans of benefits, or to fulfill legal and regulatory requirements.

North Atlantic States Carpenters Funds will use and disclose your personal information only as permitted by the Funds' benefit plans, and in compliance with all applicable laws, including, with respect to the North Atlantic States Carpenters Health Fund, the Health Insurance Portability and Accountability Act ("HIPAA").

Cookies

Cookies are small data files that a site transfers to your computer's hard drive through your web browser. These files enable the website to recognize your browser and capture and remember certain information. Cookies do not damage your computer, and they cannot be used to find out information about you or read any personal material kept on your hard-drive.

Cookies are used to compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

There are two types of cookies - "session" and "persistent" cookies. Session cookies disappear after you close your browser, whereas persistent cookies are stored for a length of time on your hard disk after which they expire automatically.
